

ORDINANCE NO.270

BE IT ORDAINED BY THE CITY COUNCIL OF ROANOKE, ALABAMA, as follows:

SECTION 1: That Subdivision (h) of Schedule 11 of Section 1 in the License Code as adopted by Ordinance No.256, be amended to read as follows (h)-Each person, firm or corporation engaged in the business of dealing in automobile accessories, including tires, when the same is the principal stock, shall pay the same amount of license as levied, prescribed and fixed for general merchants in Schedule 89 of Section 1 of said License Code.

SECTION 2: That Schedule 33 of Section 1 in the License Code, as adopted by Ordinance No.156, be amended to read as follows: 33- Butcher and Meat Markets (a) Each person, firm or corporation operating a market for buying and selling fresh or green meats, when conducted in connection with other licensed business, per year - \$20.00; (b) when not conducted in connection with other licensed business per year - \$37.50; (c) Each person, firm or corporation who maintains no established place of business who sell fresh or green meat in quantities less than by the quarter, per year- \$75.00. (This schedule not applicable to meats raised by the one selling.)

SECTION 3: That Schedule 55 of Section 1 in the License Code, as adopted by Ordinance No.256, be amended to read as follows: 55- Professions-Each Surgeon, Physician, Dentist, Oculist, Lawyer" Optometrist, Chiropractor, or Osteopath, and where doing business as a firm each member thereof, if the gross business had in the preceding year is \$1,000.00 or under-\$5.00; if gross business had in the preceding year is \$1000.00 and not more than \$2,000.00-\$10.00; if gross

business had in the preceding year is over \$2,000.00 and not more than \$3,000.00-\$15.00; if the gross business had in the preceding year is over \$3,000.00 and not more than \$4,000.00-\$20.00; if the gross business had in the preceding year is more than \$4,000.00-\$25.00. No license required by this chedule shall be issued until the applicant for such license shall first file with the City Clerk an affidavit in writing stating the gross income of the applicant for the next preceding calendar year.

SECTION 4: That Schedule 64 of Section 1 in the License Code as adopted by Ordinance No.256 be amended to read as follows: 64-Fish Peddlers or Dealers-Each person,firm or corporation selling or dealing in fish or other sea foods,not in connection with licensed meat market or butcher,per year-\$10.00.

SECTION 5: That Schedule 105 of Section 1 in the License Code as adopted by Ordinance No.256. be amended to read as follows: 105-Radios-(a) Each person,firm or corporation selling or dealing in radios and or radio supplies,when not in connection with other licensed business,per year-\$15.00;when in connection with other licensed business,per year-\$10.00.

SECTION 6: That Schedule 41 of Section 1 in License Code as adopted by Ordinance No.256, be amended to read as follows:41-Cigarettes-Each person,firm or corporation selling or dealing in Cigarettes at retail,per year-\$5.00. (B) Each person,firm or corporation selling or dealing in Cigarettes,at Wholesale,per year-\$5.00.

SECTION 7: That Section 83 of Section 1 in the License Code,as adopted by Ordinance No.256, be and the same is hereby repealed.
