ORDINANCE NO. 480

TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE TO RE-ZONE OR RE-CLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENCE "A" DISTRICT TO LOCAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES AND PROCEDURES IN CONFLICT WITH THE ENACTMENT AND ADOPTION OF THIS ORDINANCE AS TO SAID REZONING OR RE-CLASSIFICATION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

Section1. That the Zoning Ordinance of the City of Roanoke, Alabama, be amended to add Section 13.1 as follows:
13.1 Provided, however, that the following property;

Beginning, for reference, at the intersection of the center line of Alabama Highway 22 and the center line of Price Street in Roanoke, Alabama, and running thence South 31 degrees 12 minutes East along the center line of Price Street for a distance of 102 feet to a point; thence South 48 degrees 56 minutes West a distance of 24.2 feet to a point on the West right-of-way of Price Street, said point being the point of beginning of the property herein described; thence South 31 degrees 30 minutes East along the West right-of-way of Price Street a distance of 215 feet to a point; thence continuing along said right-of-way South 38 degrees 00 minutes East a distance of 100 feet to a point; thence South 49 degrees 50 minutes West a distance of 186.8 feet to a point; thence North 36 degrees 40 minutes West a distance of 309.4 feet to a point; thence North 48 degrees 56 minutes East a distance of 203.8 feet to the point of beginning, containing 1.4 acres, more or less. Also, all of that certain property owned by and in the possession of Randolph County Legion Post 53, American Legion, and known as the "American Legion" property, not heretofore included in and zoned as "Local Business District", said American Legion property being bounded on the North by Huey property and Alabama Highway 22, on the East by Alabama Highway 22, on the South by the Carson property and property of M.M. Handley and the West by Price Street,

heretofore included in and shown and designated on the Zoning Map of Roanoke as "Residence 'A' District", be and the same is hereby re-zoned or re-classified as and designate "Local Business District", as the term is used in the Zoning Ordinance of the City of Roanoke, Alabama.

Section 2. All ordinances and parts of ordinances and all procedures provided by ordinances in conflict with this ordinance or the enactment and adoption of this ordinance are, as to this ordinance, repealed.

Section 3. This Ordinance to be of force and effect upon its passage and adoption.
