ORDINANCE NO. 489

TO AMEND THE AONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE AONING MAP OF ROANOKE, ALAGAMA: TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA, FRO M RESIDENCE "C" DISTRICT TO LOCAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES AND PROCEDURES IN

CONFLICT WITH THE ENACTMENT AND ADOPTION OF THIS ORDINANCE AS TO SAID RE-ZONING OR RE-CLASSIFICATION:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

Section 1. That the zoning Ordinance and the Zoning Map of the City of Roanoke, Alabama be amended, altered and changed to show the following hereinafter described property within the City of Roanoke, Alabama, shall be changed from Residence Zone "c" to that of Local Business property, towit;

All that part and parcel of land that lies on the Easterly side of West Point Street and that lies between Gaston Street and Cotney Line Street and which runs back Easterly from said West Point Street for a depth of 200 feet; and the same being heretofore shown in the Zoning Ordinance and Zoning Map of the City of Roanoke, Alabama, as Residential "C" property, be and the same is now classified, altered and changed to that of a Local Business District Classification, and as the term is used in said Zoning Ordinance and as shown on the Zoning Map of the City of Roanoke, Alabama;

Section 2. Said Rezoning and reclassification to so rezone and reclassify said property as Local Business Property instead of Residence "C" Property;

Section 3. All Ordinances and parts of Ordinances and all procedures and requirements in conflict with this Ordinnace and provisions of other Ordinances or amended Ordinances and in conflict with this Ordinance and in the enactment thereof and the adoption thereof as to such conflicts with this Ordinance are hereby repealed;

Section 4. This Ordinance to be of force and effect
