ORDINANCE NO. 502

TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA AS AMENDED, AND THE ZONING MAP OF ROANOKE, ALABAMA, AS AMENDED: TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENTIAL OR RESIDENCE "B" DISTRICT TO LOCAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES AND PROCEEDINGS IN CONFLICT WITH THE ENACTMENT AND ADOPTION OF THE ORDINANCES AS TO SAID RE-ZONING OR CLASSIFICATION.

BE IT ORDAINED BY THE CITY COUNCIL OF ROANOKE, ALABAMA as follows:

Section 1. That the Zoning Ordinances and the Zoning map of the City of Roanoke, Alabama be amended, altered and changed from residential or Zone "B" to Local Business Property as to the following hereinafter described property:

All that part and parcel of land that lies on the Westerly side of the U. S. #431 By-Pass as to the City of Roanoke, Alabama and being near the Northerly end or extension of Harris Avenue and that lies just immediately South and contiguous of the Fincher property recently rezoned for Local Business property and is further and more particularly described as follows: Commencing at the Southeast end of the property, that is the Southeast corner on the Westerly side of the U. S. #431 By-Pass of the City of Roanoke, Alabama of the property of Elton Fincher and on which is located a new Standard Oil Filling Station, and from said starting point running thence in a Southerly direction along the Westerly side of said U. S. #431 Highway By-Pass as to the City of Roanoke, Alabama, a distance of 190 feet to a point; thence in a northwesterly direction and along the Wesley Traylor Property a distance of 238 feet to a point; thence in a Northeasterly direction along the property line of property of the Handley Mills Inc., a distance of 97 feet to a point; thence in an easterly direction along the Southerly side of the Elton Fincher property a distance of 152 feet to the beginning point; and said property being near and not far removed from the intersection of the U. S. #431 Highway By-Pass to the City of Roanoke, Alabama and East Avenue; and said property being heretofore shown in the Zoning Ordinance and map of the City of Roanoke, Alabama as Residential or Residence Zone "B", be and the same is now calssified, altered and changed to that of Local Business District Property or Zone and as shown in the Zoning Map

of the City of Roanoke, Alabama;

Section 2. Said Rezoning and Reclassification had and done as a result of a complete change in such former Residential or Residence Zone "B" District in that now a main Arterial Highway will intersect with the said East Avenue, and where there was formerly no Highway and street intersection;

Section 3. All Ordinances and parts of Ordinances and all procedures and requirements in conflict with this Ordinance and provisions of other Ordinances or amended Ordinances and in conflict with this Ordinance and in the enactment thereof and the adoption thereof, as to such conflicts with this Ordinance are hereby repealed.

Section 4. This Ordinance to be of force and effect upon its passage and adoption.
