

## AN ORDINANCE

NO. 509

To amend the Zoning Ordinance of the City of Roanoke, Alabama, as amended, and the Zoning Map of Roanoke, Alabama, as amended; to rezone or reclassify that certain property in the City of Roanoke, Alabama, from Residential or Residence "C" District to Local Business District; and to repeal all ordinances or parts of ordinances and proceedings in conflict with the enactment and adoption of the ordinance as to said rezoning or reclassification.

BE IT ORDAINED BY THE CITY COUNCIL OF ROANOKE,  
ALABAMA, AS FOLLOWS:

Section 1. That the Zoning Ordinance and the Zoning map of the City of Roanoke, Alabama, be amended, altered and changed from Residential "C" to Local Business District as to the following described property:

That certain piece, tract or parcel of land at the northwesterly intersection of U. S. Highway 431 and an unnamed, unpaved street or alley leading from Riley Street to said Highway south of the Wilkie Clark property, in the City of Roanoke, Alabama, fronting 200 feet on the West side of said highway and extending back in a westerly direction of uniform width 200 feet; also, a strip of land on the West side of said U. S. Highway 431 extending in a northerly direction from the aforescribed property a distance of 350 feet, more or less, to that portion of the Hall property located at the southwesterly intersection of College Street and Highway 431 presently zoned "Local Business District", and extending back in a westerly direction of uniform width 150 feet.

And said property being heretofore shown in the Zoning Ordinance and Zoning Map of the City of Roanoke, Alabama, as Residential or Residence "C" be and the same is now classified, altered and changed to that of Local Business District Property or Zone as shown in the Zoning Map of the City of Roanoke, Alabama.

Section 2. Said rezoning and reclassification is had and done as a result of the demand of said property as Local Business Property.

Section 3. All ordinances and parts of ordiannces and all procedures and requirements in conflict with this ordinance and provisions of other ordinances or amended ordinance in conflict with this ordinance and the enactment and adoption thereof, to the extent of such conflict, are hereby repealed.

Section 4. This ordinance to be of force and effect upon its passage and adoption.
