ORDINANCE NO. 534

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM LOCAL BUSINESS DISTRICT AND RESIDENCE "B" DISTRICT TO GENERAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, Alabama, and the Zoning Map of the City of Roanoke, Alabama, be amended, altered and changed to rezone and reclassify in the manner hereinafter provided the following described property located in the City of Roanoke, Randolph County, Alabama, to-wit:

Beginning at a point on the northerly margin of East Main Street, also known as Rock Mills Road, which point is the southeasterly corner of the Anglin lot and the southwesterly corner of the Enloe lot, and running thence along the northerly margin of East



Main Street a distance of 210 feet to the intersection of Harris Avenue; thence in northerly direction along the westerly margin of Harris Avenue 500 feet to a point; thence in a westerly direction and parallel to East Main Street 210 feet to the Anglin lot line; thence in a southerly direction along the Anglin lot line 500 feet to the point of beginning.

Section 2. That that portion of the above described property presently zoned or classified Local Business District, and being approximately the southerly 200 feet thereof, be rezoned and reclassified to General Business District; and the remaining portion of the above described property now zoned or classified Residence "B" District be rezoned and reclassified to General Business District; and that from and after the passage and adoption of this ordinance, the property described in Section 1 above shall be classified as General Business District property and shall be subject to the used, regulations and restrictions as to General Business District property as set forth in the Zoning Ordinance of the City of Roanoke, Alabama, as the same may be now or hereafter amended.

Section 3. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 4. This Ordinance shall be in force and effect upon its passage and adoption as provided by law.

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENCE "A" DISTRICT TO GENERAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, Alabama, and the Zoning Map of the City of Roanoke be amended, altered and changed to rezone or reclassify from Residence "A" District to General Business District the following described property situated in the City of Roanoke, Randolph County, Alabama, to-wit:
