Section 2. Every candidate seeking election as a member of the City Council of the City of Roanoke, Alabama in municipal elections hereafter conducted in the City of Roanoke, Alabama shall, at the time of qualifying, pay to the City of Roanoke, Alabama, at the office of the City Clerk, a qualification fee of \$15.00.

Section 3. No person shall be deemed or considered a candidate for election as Mayor or as a member of the City Council of the City of Roanoke, Alabama, unless and until the qualification fee imposed hereunder shall have been paid as provided herein, and unless the same is paid as provided herein, such persons name shall not appear as a candidate on any ballot.

<u>Section 4</u>. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

<u>Section 5</u>. This ordinance shall be in force and effect upon its passage and adoption as provided by law.

ORDINANCE NO. 582

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENCE "A" DISTRICT TO RESIDENCE "B" DISTRICT AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, alabama, and the Zoning Map of the City of Roanoke be amended, altered and changed to rezone or reclassify from Residence "A" District to Residence "B" District the following described property situated in the City of Roanoke, Randolph County, Alabama, to-wit:

8 acres, more or less, in the East half of the Southwest Quarter . of the Southwest Quarter of Section 25, Township 21 South, Range 12 East, and being more particularly described as follows: For point of reference, begin at the Southwest Corner of the above described Section 25; thence North along the Section line a distance of 1360 feet, more or less, to a point located on the south Right of way of Pope Road; thence, proceed in an Easterly direction along the south right of way of Pope Road a distance of 660 feet, more or less, to a point, said point being the point of beginning. From said point of beginning, proceed in a Southerly direction a distance of 600 feet, more or less, to a point and corner; thence, in an Easterly direction a distance of 530 feet, more or less, to a point and corner located on the west right of way of Bonner Drive as shown on the Plat of Lakeview Estates Subdivision, Richard Laird Addition (said subdivision being hereinafter referred to as "Subdivision"); thence, in a Northwesterly direction along the west side of said Bonner Drive right of way a distance of 10 feet, more or less, to a point and corner where said Road ends according to the Plat of said Subdivision; thence, proceed in a Northeasterly direction a distance of 269 feet, more or less, along the end of Bonner Drive and the north line of Lots 11 & 12 of said Subdivision to a point and corner; thence, proceed in a Northwesterly direction 240 feet, more or less, along the south line of Lots 5 & 6 of said Subdivision to a point and corner; thence, proceed in a Southwesterly direction 117 feet, more or less, along the Southeast line of Lot 2 of said Subdivision to a point and corner; thence, proceed in a Northerly direction a distance of 325 feet, more or less, along the west line of Lots 1 & 2 of said Subdivision to a point and corner located on the South right of way of the Pope Road; thence proceed in a Westerly direction along the south right of way of Pope Road a distance of 465 feet, more or less, to the point of beginning.

Section 2. From and after the passage and adoption of this Ordinance, the property described in Section 1 above shall be classified as Residence "B" District property and shall be subject to the uses, regulations and restrictions as to Residence "B" District property as set forth in the Zoning Ordinance of the City of Roanoke, Alabama, as the same may be now or hereafter amended.

Section 3. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 4. This Ordinance shall be in force and effect upon its passage and adoption as provided by law.

ORDINANCE NO.583

AN ORDINANCE FURTHER AMENDING SECTIONS 2 AND 9 OF ORDINANCE NO. 482 OF THE CITY OF ROANOKE, ALABAMA LEVYING A PRIVILEGE OR LICENSE TAX AGAINST PERSON, FIRMS OR CORPORATIONS ENGAGED IN THE BUSINESS OF SELLING TANGIBLE PERSONAL PROPERTY AT RETAIL OR CONDUCTING PLACES OF AMUSEMENT IN THE CITY OF RAONOKE, ALABAMA OR WITHIN ITS POLICE JURISDICTION; INCREASING THE RATES OF SUCH TAX AND FIXING THE EFFECTIVE DATE OF SUCH INCREASE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. Section 2 of Ordinance No. 482 of the City of Roanoke, Alabama adopted by the City Council and approved by the Mayor of said City on March 8, 1965, is hereby amended so that said Section 2 shall read in its entirety as follows:

Section 2. Levy of Tax in the City. For the
