## CITY TAX ORDINANCE

No. 377

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1, 1949.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF ROANOKE ALABAMA, as follows:

SECTION 1: That taxes are hereby levied for the City of Roanoke Alabama, on all real and personal property and other properties and franchises located and taxable in the City of Roanoke, Alabama, for the year 1949, based upon the valuation as assessed for state taxation during last year, as follows:

- 1. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation to be applied exclusively to the payment of bonds heretofore issued and the interest thereon.
- 2. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for general municipal purposes.

## ORDINANCE #378

An Ordinance clarifying, regulating Parking in Parking Meter Zones and Limits and specifying Parking Meter Restrictions, regulations, and Violations.

Section L. DEFINITIONS:

- a. Vehicle shall mean any device in, upon, or by which any person or property is or may be transported upon a Highway, Road, Street, Avenue, Alley, or other places used for transporting persons or property.
  - b. Restricted Street shall mean that part of any public street,
