CITY TAX ORDINANCE

NO. 513

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1, 1969.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

SECTION 1. That taxes are hereby levied for the City of Roanoke, Alabama, on all real and personal property and other properties and franchises located or taxable in the City of Roanoke, Alabama, for the year 1969, based upon the valuation as assessed for state taxation during last year, as follows:

1. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation to be applied exclusively to the payment of bonds heretofore issued and the interest thereon.
2. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for general municipal purposes.
3. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for school purposes, School District No. 2 Randolph County, Alabama.

AN ORDINANCE

NO. 514

TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AS AMENDED, AND THE ZONING MAP OF ROANOKE, ALABAMA, AS AMENDED: TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENTIAL OR RESIDENCE ZONE "A" AND "B", BOTH OR EITHER TO THAT OF LOCAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THE ENACTMENT AND ADOPTION OF THE PROCEEDINGS THERE IN SO FAR AS THEY CONFLICT WITH THE PRESENT REZONING AND RECLASSIFICATION ORDINANCE:

BE IT ORDAINED BY THE CITY COUNCIL OF ROANOKE, ALABAMA, as follows:

Section 1. That the Zoning Ordinances and the Zoning Map of the City of Roanoke, Alabama be amended, altered and changed from Residential "A" or "B" or either to that of Local Business District as to the following hereinafter described property:

The lands of, or formerly of Cosby Smith and lying on the Easterly side of the U. S. Highway #431 By-Pass of the City of Roanoke, Alabama and located and being in and a part of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ and the East one half ($\frac{1}{2}$) of the SE $\frac{1}{4}$ of Section 26, Township 21-S, and Range 12-E in Randolph County, Alabama and being further described as follows:

Beginning at the N. E. Corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 26, Township 21-S, Range 12-E in Randolph County, Alabama and run along a fence line S 17 degrees, 49 minutes East a distance of 1,168 feet to a point; thence S 21 degrees, 59 minutes East a distance of 520 feet to a point at a Concrete Marker with an iron pipe in the center; thence S 4 degrees, 41 minutes West a distance of 158.7 feet to a Concrete Right of Way Marker 12+25; thence S 50 degrees, 02 minutes West a distance of 41.8 feet to a concrete Right of Way Marker ASHD; thence North 78 degrees, 50 minutes West a distance of 63 feet to a Concrete Right of Way Marker 1035+45; thence North 28 degrees, West 1,058.4 feet to a Concrete Right of Way Marker P. C. 1046+03.4; thence North 28 degrees West a distance of 413.6 feet to a Concrete Right of Way Marker P. O. C. 1051+00; thence North 35 degrees, 40 minutes West a distance of 156.2 feet to a Concrete Right of
