CITY TAX ORDINANCE

NO. 635

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1, 1986.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL FO THE CITY OF ROANOKE, ALABAMA, as follows:

SECTION 1: That taxes are hereby levied for the City of Roanoke, Alabama, on all real and personal property and other properties and franchises located or taxable in the City of Roanoke, Alabama for the year 1986, based upon the valuation as assessed for state taxation during last year as follows:

1. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation to be applied exclusively to the payment of bonds heretofore issued and the interest thereon.
2. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for general municipal purposes.
3. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for school purposes, School District No. 2, Randolph County, Alabama.
