

ORDINANCE #668 - ANNEXATION

Ordinance #668 was introduced in writing by Councilmember Bell.

ORDINANCE NO. 668

AN ORDINANCE TO AMEND CORPORATE LIMITS OF THE CITY OF ROANOKE, ALABAMA. BY INCLUDING IN THE CORPORATE LIMITS OF ROANOKE, ALABAMA, CERTAIN PROPERTIES AT THE REQUEST OF THE OWNERS OF SAID PROPERTY AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BET IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA AS FOLLOWS:

SECTION 1. That the Corporate Limits of the City of Roanoke, Alabama be altered and changed within the Corporate Limits of teh City of Roanoke, Alabama, the following described property situated in Randolph County Alabama, to-wit:

A. THE PROPERTY OF EVERGREEN TIMBERLANDS CORPORATION;

A TRACT of land beginaing at the Roanoke city limits on the north side of County Road 79 and running along the north side of said road a distance of 1,056 feet and being 20 feet in width.

Above described property lying in Sec. 23; T-21-S; R-12-E; in Randolph County, Alabama.

B. THE PROPERTY OF MIRIAM WOOD HAYWOOD AND NANCY WOOD JONES:

Beginning at a large rock located on the SW corner of NE $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 23, Township 21 South, Range 12 East, in Randolph County; thence running North 11 degree and Zero minutes east a distance of 678 feet to a point, thence North 63 degrees and Zero minutes West a distance of 48 feet to the point of beginning of land to be reserved; tehnce north 51 degrees and Zero minutes east a distance of 1050 feet, thence north 85 degrees and 45 minutes east a distance of 1368.5 feet, thence South 10 degrees and 45 minutes west a distance of 1281.5 feet, thence South 47 degrees and 15 minutes West a distancc of 446.1 feet; thence north 63 degrees and Zero minutes West a distance of 1800 feet to the point of beginning of land to be reserved.

Above described land lying in NE $\frac{1}{4}$  of NE $\frac{1}{4}$  and SE $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 23, and NW $\frac{1}{4}$  of NW $\frac{1}{4}$  and SW $\frac{1}{4}$  of NW $\frac{1}{4}$ ; Section 24, Township 21, Range 18 East, in Randolph County, Alabama and containing 48.22 Acres more or less.

SECTION 2. FROM AND AFTER THE DATE OF THE PUBLICATION OF THIS ORDINANCE THE PROPERTY DESCRIBED IN SECTION 1 ABOVE SHALL BE INCLUDED IN THE CORPORATE LIMITS OF THE CITY OF ROANOKE, ALABAMA, PURSUANT TO ARTICLE 2, CHAPTER 42, TITLE 11, CODE OF ALABAMA, 1975.

SECTION 3: ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE ARE HEREBY REPEALED

SECTION 4. THIS ORDINANCE SHALL BE ENFORCED AND EFFECTIVE UPON ITS PASSAGE AND ADOPTION AS PROVIDED BY LAW.
