

AN ORDINANCE TO AMEND THE CORPORATE LIMITS OF THE CITY OF ROANOKE, ALABAMA BY INCLUDING IN THE CORPORATE LIMITS OF ROANOKE, ALABAMA CERTAIN PROPERTIES AT THE REQUEST OF THE OWNERS OF SAID PROPERTY AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA AS FOLLOWS:

Section 1: That the corporate Limits of the City Of Roanoke, Alabama be altered and changed to include within the Corporate Limits fo the City of Roanoke, Alabama, the following described property situated in Randolph County, Alabama, to-wit:

THE PROPERTY OF WORD OF LIFE BAPTIST CHURCH

PARCEL #1

Beginning at a point on the West side of the paved Highway leading from Roanoke, Ala. to Omaha, which point is on the North Line of said forty; thence run West a distance of 525 feet to a corner; thence run in a South-eastern direction a distance of 573 feet to the West side of said paved Omaha and Roanoke Public Road; thence run North along said Road to the point of beginning. Containing one acre more or less. The distance along the Highway being 415 feet.

PARCEL #2

One acre of land, more or less, on the East side of the blacktop public highway leading from Roanoke to Graham and known as the Omaha or Springfield Road, in the Southwest Quarter of the Southeast Quarter (SW1/4 of SE 1/4) of Section 19, Township 21, Range 13, in Randolph County, Alabama, more particularly described as follows: Beginning at a point on the East right of way line of said public road at the southwest corner of the J. C. McDow two acre tract or lot purchased from the within grantors, and running thence in a southerly direction along the said East right of way line of said public road two hundred ten (210) feet to a point and corner; thence in an easterly direction and parallel with the south line of said McDow property two hundred ten (210) feet to a point and corner; thence in a northerly direction and parallel with said public road two hundred ten (210) feet to a point and corner; thence in a westernly direction and along the south line of said McDow property two hundred ten (210) feet to the point of beginning, together with all additions and improvements thereon, being more particularly the WORD OF LIFE Baptist Church Parsonage now being constructed thereon.

PARCEL #3

A tract of land with a building located thereon described as follows: Beginning at the Southeast corner of the WORD OF LIFE Baptist Church lot, which corner is on the west edge of the Roanoke to Omaha paved public road; thence run in a southern direction along the west side of said highway a distance of 296 feet to a corner; thence run in a western direction a distance of 375 feet to a corner; thence run in a northeastern direction a distance of 264 feet to the said WORD OF LIFE Church lot; thence run in an eastern direction along said Church lot a distance of 320 feet to the beginning corner. Located in the SE 1/4 of SW 1/4, Section 19, TP.21,

Range 13.

Section 2. From and after the date of the publication of this Ordinance the property described in Section 1 above shall be included in the Corporate Limits of the City of Roanoke, Alabama, pursuant to Article 2, Chapter 42, Title II Code of Alabama 1975.

Section 3. All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 4. This Ordinance shall be in force and effect upon its passage and adoption as provided by law.
