
GRADE ORDINANCE NO. 418

An Ordinance to provide for and establish the Grade of Avenue "A", or that portion thereof that lies between College Street and Government Street in the City of Roanoke, Alabama:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

That the Grade of Avenue "A", or that portion thereof that lies between College Street and Government Street in the City of Roanoke, Alabama, is hereby established;

All of the above lying and being in the City of Roanoke, Alabama, be and the same is hereby fixed and established as the Grade of said Avenue "A", or that portion thereof that lies between College Street and Government Street as is shown by and in accordance with the maps, plats, or profiles and grades, both as to the center of said Avenue "A", or portions thereof, and the Curb Line or Lines of the same, all of which said Maps, Plats or Profiles are in the Office of the City Clerk of the said City of Roanoke, Alabama, and in the City Hall thereof.

Said Maps, Plats, or Profiles as prepared by the Ladd Engineering Company, Consulting Engineers, have heretofore been exhibited to the said Council of the City of Roanoke, Alabama, approved by said Council and are now subject to inspection in the Office of the City Clerk, Roanoke, Alabama.

THIS ORDINANCE shall take effect from and after its passage, approval and publication as required by Law.

 IMPROVEMENT ORDINANCE

NO. 419.

AN ORDINANCE TO PROVIDE FOR CERTAIN IMPROVEMENTS on, or a part or portion of Avenue "A", in the City of Roanoke, Alabama, and to provide for the kind and character of improvements to be made and the method to be employed in paying for the same:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

(a). That Avenue "A" commencing on the Southerly side and edge of College Street and running thence in a Southerly direction 750 feet along said Avenue "A" to a point be paved a width of 18 feet, which is to say 9 feet on each side of the center line thereof; and that Curb and Gutter be placed along each side of said Paving throughout its entire length;

(b). That Avenue "A" commencing on the Northerly side of Government Street, and at the edge of Government Street, and running thence in a Northerly direction 541.5 feet along said Avenue "A" to a point be paved a width of 18 feet, which
