
GRADE ORDINANCE

No. 448

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE,
ALABAMA, as follows:

An Ordinance to provide for and establish the Grade on that portion of Lakeview Drive as hereinafter defined, which said portion of said Street, Avenue or thoroughfare is located in the City of Roanoke, Alabama, as follows;

A. That portion of Lakeview Drive commencing at a point in the center line of Lakeview Drive at the center line of the intersection of Lakeview Drive and Stewart Drive and running thence East along Lakeview Drive a distance of 364 feet to the East side of said Lakeview Drive;

And all of the above described portion of Lakeview Drive being and lying within the City of Roanoke, Alabama, be and the same is hereby fixed and established as the Grade for said portion of said Lakeview Drive, and as shown by and in accordance with a map, plat or profile and grade both as to the center of said Lakeview Drive or said portion thereof, and the Curb Line, or lines of the same, all of said named plat, map or profile are in the office of the City Clerk of said city and at the city hall thereof.

Said map, plat or profile prepared by F. J. Jackson, City Engineer of the City of Roanoke, Alabama, and the same have heretofore been exhibited to said Council of the City of Roanoke, Alabama, approved by said Council, and the same is subject to inspection in the office of the City Clerk of the City of Roanoke, Alabama.

This Ordinance shall take effect from and after its passage, approval, and publication as required by Law.
