

ORDINANCE NO. 281

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1st, 1937,  
BE IT ORDAINED BY THE MAYOR AND COUNCIL, OF THE CITY OF ROANOKE,  
ALABAMA, as follows:

SECTION 1: That taxes are hereby levied for the City of Roanoke,  
on all real and personal property and other properties and franchises  
located or taxable in the City of Roanoke, Alabama, for the year 1937,  
based upon the valuation of such real and personal properties and  
other properties and franchises, as assessed for state taxation dur-  
ing last year, as follows:

1: A tax of One-half of One per centum, or Fifty cents on each  
One Hundred Dollars of valuation, for general Municipal purposes.

2: A tax of One-half of One per centum, or Fifty cents on each  
One Hundred Dollars valuation, to be applied exclusively to the pay-  
ment of Bonds heretofore issued and the interest thereon.
