AN ORDINANCE
NO. 530

TO FIX THE MAXIMUM FINE FOR VIOLATION OF ALL ORDINANCES HERETOFORE OR HEREAFTER ADOPTED OR ENACTED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA AT TWO HUNDRED DOLLARS (\$200.00) IN ADDITION TO ANY OTHER LAWFUL PURNISHMENT.

Section 1. Any person violating any ordinance heretofore or hereafter adopted or enacted by the City Council of the City of Roanoke, Alabama may, on conviction therefor, be fined not more than two hundred dollars (\$200.00), in addition to any other lawful purnishment now or hereafter authorized or permitted by law.

Section 2. All ordinances and parts of ordinances and all procedures and requirements in conflict with this ordinance, and provisions of other ordinances or amended ordinances in conflict with this ordinance and the enactment and adoption hereof, to the extent of such conflict, are hereby repealed.

Section 3. This ordinance shall be of force and effect upon its passage and adoption or as otherwise provided by law.

CITY TAX ORDINANCE
NO. 531

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1, 1972.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY
OF ROANOKE, ALABAMA, as follows:

Section 1: That taxes are hereby levied for the City of Roanoke, Alabama, on all real and personal property and other properties and franchises located or taxable in the City of Roanoke, Alabama, for the year 1972, based upon the valuation as assessed for state taxation during last year, as follows:

1. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation to be applied exclusively to the payment of bonds heretofore issued and the interest thereon.
2. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for general municipal purposes.
3. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for school purposes, School District No. 2, Randolph County, Alabama.
