

Beginning at the Northeast corner of Section 19, Township 21, Range 13 and run South along the east section line of Sections 19, 30, 31 in Township 21, Range 13, and continue South along the east section line of Sections 6, 7 and Fractional Section 18, Township 22, Range 13, to the Chambers County line; thence run West along the Chambers County line in Fractional Section 18, Township 22, Range 13, and continue west along the Chambers County line in Fractional Sections 13, 14, 15 and 16, Township 22, Range 12 to the Southwest corner of Fractional Section 16, Township 22, Range 12, thence North along the west section line of Fractional Section 16, Sections 9 and 4, Township 22, Range 12, and continue North along the west section line of Sections 33, 28, and 21, Township 21, Range 12, to the Northwest corner of Section 21, Township 21, Range 12; thence east along the north section line of Sections 21, 22, 23 and 24, Township 21, Range 12 and Section 19, Township 21, Range 13 to the beginning point.

And the said property within said boundaries may be further described as being Sections 21, 22, 23, 24, 25, 26, 27, 28, 33, 34, 35 and 36 in Township 21, Range 12; Sections 19, 30 and 31 in Township 21, Range 13; Sections 1, 2, 3, 4, 9, 10, 11, 12, Fractional Sections 13, 14, 15 and 16 in Township 22, Range 12; and Sections 6, 7 and Fractional Section 18 in Township 22, Range 13.

2. That the City Council petitions and requests the Honorable Ted Little and the Honorable Richard J. Laird to introduce and seek the passage of an Act of the Legislature of the State of Alabama extending said City Limits as indicated above.

3. That the Mayor transmit a copy of this Resolution to the Honorable Ted Little and the Honorable Richard J. Laird.

ORDINANCE NO. 581

AN ORDINANCE TO ESTABLISH AND FIX A QUALIFICATION FEE TO BE IMPOSED UPON ALL CANDIDATES SEEKING ELECTION IN MUNICIPAL ELECTIONS HEREAFTER CONDUCTED IN THE CITY OF ROANOKE, ALABAMA, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. Every candidate seeking election as Mayor of the City of Roanoke, Alabama in municipal elections hereafter conducted in the City of Roanoke, Alabama shall, at the time of qualifying, pay to the City of Roanoke, Alabama, at the office of the City Clerk, a qualification fee of \$25.00.

Section 2. Every candidate seeking election as a member of the City Council of the City of Roanoke, Alabama in municipal elections hereafter conducted in the City of Roanoke, Alabama shall, at the time of qualifying, pay to the City of Roanoke, Alabama, at the office of the City Clerk, a qualification fee of \$15.00.

Section 3. No person shall be deemed or considered a candidate for election as Mayor or as a member of the City Council of the City of Roanoke, Alabama, unless and until the qualification fee imposed hereunder shall have been paid as provided herein, and unless the same is paid as provided herein, such persons name shall not appear as a candidate on any ballot.

Section 4. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5. This ordinance shall be in force and effect upon its passage and adoption as provided by law.

ORDINANCE NO. 582

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENCE "A" DISTRICT TO RESIDENCE "B" DISTRICT AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.
