ORDINANCE NO. 533

AN ORDINANCE TO FURTHER REGULATE PARKING UPON THE PUBLIC STREETS OF ROANOKE, ALABAMA; TO LIMIT CONTINUOUS PARKING IN ANY RESTRICTED PARKING ZONE OR PARKING METER ZONE; AND TO FIX THE PUNISHMENT FOR VIOLATION HEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. It shall be unlawful for any person to park, put or place any motor vehicle in any restricted parking zone or parking meter zone, as defined by City of Roanoke Ordinance No. 378, adopted December 12, 1949, and to cause or allow the same to remain therein continuously for more than two (2) hours, except on Sunday.

Section 2. Any person convicted of violating this ordinance shall be punished by a fine of not less than two dollars (\$2.00) nor more than two hundred dollars (\$200.00), or by imprisonment in the municipal jail or hard labor for the City of Roanoke not to exceed six (6) months, or both.

Section 3. This ordinance shall supplement and be in addition to other prior or existing ordinances regulating parking; however, all ordinances or parts of ordinances which conflict with this ordinance are repealed.

Section 4. This ordinance shall go into effect upon passage and publication as required by law.

ORDINANCE NO. 534

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM LOCAL BUSINESS DISTRICT AND RESIDENCE "B" DISTRICT TO GENERAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, Alabama, and the Zoning Map of the City of Roanoke, Alabama, be amended, altered and changed to rezone and reclassify in the manner hereinafter provided the following described property located in the City of Roanoke, Randolph County, Alabama, to-wit:

Beginning at a point on the northerly margin of East Main Street, also known as Rock Mills Road, which point is the southeasterly corner of the Anglin lot and the southwesterly corner of the Enloe lot, and running thence along the northerly margin of East
