ORDINANCE NO. 566

AN ORDINANCE TO FURTHER REGULATE PARKING AND THE OPERATION OF MOTOR VEHICLES WITHIN THE CITY LIMITS AND POLICE JURISDICTION OF THE CITY OF ROANOKE, ALABAMA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. PROHIBITED PARKING.

(1) No person shall park a motor vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of lawful traffic movement and with the right wheels of the vehicle within twelve (12) inches of the curb or edge of the roadway, except as otherwise provided by this ordinance.

(2) No person shall park a motor vehicle within an alleyway in such a manner or under such condition as to block the free movement of vehicle traffic.

(3) No person shall park a motor vehicle upon any street or roadway for the purpose of displaying such vehicle for sale, holding or storing such vehicle or washing, greasing or repairing such vehicle, except repairs necessitated by an emergency.

Section 2. PROHIBITED STOPPING, STANDING OR PARKING.

(1) Except when necessary to avoid conflict with other traffic or in compliance with the direction of a police officer or traffic control device, no person shall stop, stand or park a motor vehicle in any of the following places:

(a) On a sidewalk or on any grass plot or paved area between the sidewalk and curb.

(b) In front of a public or private driveway.

(c) Within an intersection.

(d) Within fifty (50) feet of a driveway entrance

to any fire station or police station, or on the side of a street opposite the entrance to any fire station or police station within seventy-five (75) feet of said entrance.

(e) At any place where an official sign prohibits stopping or parking.

(f) On private property unless with permission of the owner or occupant of said property.

Section 3. ANGLE PARKING.

(1) The Chief of Police shall determine from time to time upon which streets or portion thereof angle parking shall be permitted, and shall make or cause to be marked or placed signs or other marks designation the same. Angle parking shall not be permitted at any place where passing traffic would be caused or required to drive upon the lefthand side of the street.

(2) Upon streets or portions of streets where angle parking has been designated and marked, no person shall park a motor vehicle except within the designated spaces and in the manner provided for such parking. No person shall park a vehicle so as to occupy more than one such parking space or part thereof.

(3) No person shall park a vehicle which exceeds twenty (20) feet in overall length in any place marked for angle parking except in a loading zone.

Section 4. LOADING ZONE.

(1) The Chief of Police shall from time to time designate curb loading zones and shall cause appropriate markings and signs to be placed designation the same.

(2) No person shall stop, stand or park a motor vehicle for any purpose or length of time in a designated loading zone

other than for the expeditious unloading and delivery or pickup and loading of materials at the place of business served by such loading zone between the hours of 7:00 a. m. and 6:00 p.m. Monday through Saturday.

(3) No person shall stop, stand or park a vehicle for such purposes in any loading zone for a period of time in excess of thirty (30) minutes except with special written permission from the Chief of Police

Section 5. Any person violating any provision of this ordinance shall, upon conviction, be punished by a fine of not less than One Dollar (\$1.00) nor more than Five Hundred Dollars (\$500.00), and in addition thereto, may be imprisoned or sentenced to hard labor for the City of Roanoke, Alabama, for a period not exceeding six (6) months:

Section 6. The provisions of this ordinance are cumulative and shall not be deemed to repeal existing ordinances, except to the extent such ordinances or parts thereof are clearly inconsistent with the provisions of this ordinance. Such ordinances or parts thereof which are clearly inconsistent with the provisions of this ordinance are hereby repealed.

Section 7. The provisions of this ordinance are severable. If any part of this ordinance is declared invalid or unconstitutional, such declaration shall not affect the part which remains.

Section 8. This ordinance shall be in force and effect upon its passage and adoption as provided by law.
