AN ORDINANCE FIXING AND ESTABLISHING SPEED LIMITS IN THE
CITY OF ROANOKE ALABAMA AND ITS POLICE JURISDICTION:

BE IT ORDAINED by the City Council of the City of Roanoke, Alabama as follows:

SECTION 1. No person shall operate a motor vehicle at a greater speed than fifty-five (55) miles per hour in the following listed zones of the City:

- (1) On Alabama Highway No. 1 at the South City Limits (MP 182.86) northerly to MP 185.19 a distance of 2.43 miles.
- (2) On Alabama Highway No. 1 from East Avenue (MP 186.24) Northerly to the North City Limits (MP 188.69) a distance of 2.45 miles.
- (3) On Alabama Highway No. 22 from West City Limits (MP 159.13) easterly to Quail Run Drive (MP 159.61) a distance of 0.48 miles.
- (4) On Alabama Highway No. 22 from MP 162.92 to the East City Limits (MP 163.50) a distance of 0.58 miles.

SECTION 2. No person shall operate a motor vehicle at a greater speed than fifty (50) miles per hour in the following listed zones of the City:

- (1) On Alabama Highway No. 1 from MP 185.29 northerly to MP 185.60 a distance of 0.31 miles.
- (2) On Alabama Highway No. 22 from MP 162.55 easterly to MP 162.92 a distance of 0.37 miles.

SECTION 3. No person shall operate a motor vehicle at a greater speed than forty-five (45) miles per hour in the following listed zones of the City:

- (1) On Alabama Highway No. 1 from MP 185.60 northerly to East Avenue (MP 186.24) a distance of 0.64 miles.
- (2) On Alabama Highway No. 22 from Quail Run Drive (MP 159.61) easterly to Main Street Intesection (MP 160.43) a distance of 0.82 miles.
- (3) On Alabama Highway No. 22 from Alabama Highway No. 1 (MP 162.03) easterly to MP 162.55 a distance of 0.52 miles.

SECTION 4. No person shall operate a motor vehicle at a greater speed than thirty five (35) miles per hour in the following listed zones of the City:

- (1) On Alabama Highway No. 22 from West Main Street (MP 160.43) easterly to Stewart Street (MP 160.89) a distance of 0.46 miles.
- (2) On Alabama Highway No. 22 from 550 feet west of Jackson Street (MP 161.59) easterly to Alabama Highway No. 1 (MP 162.03) a distance of 0.44 miles.

SECTION 5. No person shall operate a motor vehicle at a greater speed than thirty (30) miles per hour in the following listed zones of the City:

- (1) On Alabama Highway No. 22 from Stewart Street (MP 160.89) easterly to 550 Feet west of Jackson Street (MP 161.59) a distance of 0.07 miles.

SECTION 6. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 7. This ordinance shall become effective immediately upon its passage, approval and publication as provided by law.


