AN ORDINANCE NO. 528

TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA AS AMENDED, AND THE ZONING MAP OF ROANOKE, ALABAMA, AS AMENDED: TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA AS RESIDENCE "B" FREE OF RESIDENCE "A" ZONE REQUIREMENTS, AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN SO FAR AS THEY CONFLICT WITH AND ONLY TO THE EXTENT IN CONFLICT WITH THE ENACTMENT AND ADOPTION OF THE ORDINANCES AS TO SAID REZONING AND RECLASSIFICATION:

BE IT ORDAINED BY THE CITY COUNCIL OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. That the Zoning Ordinances and the Zoning Map of the City of Roanoke, Alabama, as amended, be amended, altered and changed from Residential Zone "A" to that of Residential Zone "B", and that the same be free of Residence Zone "A", as to the following property in the City of Roanoke, Alabama, towit:

Commencing at the Northwest intersection of Vaughn Street and West Point Street in the City of Roanoke, Alabama, and running thence in a Northwesterly direction along the Northerly side of West Point Street to the former Homer Akin residence property, thence Northeasterly along said property to the McGilvray-Tate Residential property, thence in southern direction along the McGilvray-Tate property to Vaughn Street, thence along the Northerly side of Vaughn Street in a Westerly or Southwesterly direction to the be-ginning point, and said intersection.

And said property being heretofore shown in the Zoning Ordinance and Map of the City of Roanoke, Alabama as Residential Zone "A" property, be and the same is now classified, altered and changed to that of Residential Zone "B", and the same free of said Residence Zone "A" requirements and the same to be shown in the Zoning Ordinance and Zoning Map of the City of Roanoke, Alabama now as Residential, Zone "B";

Section 2. Said Rezoning and Reclassification done as a result of improving said property and rezoning the same from Residential "A" to that of Residential "B";
