ORDINANCE NO. 609

A ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, TO ZONE OR CALSSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA, TO RESIDENTIAL "A" AS PER THE CURRENT ZONING ORDINANCE OF THE CITY OF ROANOKE AND TO REPEAL ALL ORDINANCES OR PART OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF ROANOKE, ALABAMA, AS FOLLOWS:

SECTION I - That the Zoning Ordinances of the City of Roanoke, Alabama, and the Zoning Maps of the City of Roanoke be amended, altered and changed to reflect the zoning and classification of the following described property situated in the city of Roanoke, Randolph County, Alabama, to Residential "A", to-wit:

8.6 acres of land, in the NW 1/4 of the NE 1/4, Section 36, T-21-S, R-12-E in Randolph County, Alabama, and being described as follows: For reference begin at a steel rod on the SW corner of Lot 3 of the Sub-division of the Estate of Mrs. H. H. Cauthen as shown on recorded plat in Plat Book 1, page 84, in the Office of the Judge of Probate, Randolph County, Wedowee, Alabama; thence run N 00°-30' W along the west line of said Lot 3 a distance of 100 feet to an iron pipe at the point of beginning; thence continue N 00°-30' W along the west line of said subdivision a distance of 580.2 feet to an iron pipe corner of the SE corner of the Henry G. Davis Sub-division as shown in Plat Book No. 1, page no. 71; thence S 89°-30' W a distance of 604 feet to a point on the east right-of-way line of County Road No. 87 (Omaha Road); thence S 8°-02' W along said east right-of-way line a distance of 586.4 feet to a point; thence N 89°-30' E a distance of 689.5 feet to the point of beginning.

SECTION II - From and after the passage and adoption of this ordinance the property described in Section I above shall be classified as Residential "A" District and shall be subject to the uses, regulations and restrictions as to Residential "A" District property as set forth in zoning ordinance of the City of Roanoke, Alabama, as the same may be now or hereafter amended.

SECTION III - All ordinances and part of ordinances in conflict with this ordinance are hereby repealed.

SECTION IV - This ordinance shall be in force and effect upon its passage and adoption as provided by law.
