

## ORDINANCE NO. 647

AN ORDINANCE CALLING THE GENERAL ELECTION OF THE MAYOR AND COUNCIL MEMBERS FOR THE CITY OF ROANOKE, ROANOKE, ALABAMA TO BE HELD ON TUESDAY, AUGUST 23, 1988.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

Section 1. Notice is hereby given that Tuesday, August 23, 1988, an election for the purpose of electing a Mayor and five (5) Council Members for the City of Roanoke, will be held, and that all registered and qualified electors of Roanoke, Alabama, and have resided therein for thirty (30) days or more preceding the date of such election, will be authorized to participate in said election.

Section 2. The polls will be opened at:

District 1 - Cattle Barn Cafeteria - Corner of Industrial Blvd. and Chestnut Street.

District 2 - National Guard Armory Old Highway 431 South

District 3 - 3-D Cash and Carry - North 431 ByPass

District 4 - Kiwanis Club building, North Highland

District 5 - Fire Station - Chestnut Street

Polls will be open on Tuesday, August 23, 1988, and at a runoff election, if necessary, to be held on Tuesday, September 13, 1988; beginning at 8:00 a.m. and will close at 6:00 p.m.

Section 3. The time for qualifying will be from 8:00 a.m. beginning Tuesday, June 21, 1988, until 5:00 p.m. in the City Clerk's office at Roanoke City Hall, Monday through Friday until Tuesday, July 19, 1988, which is final date to qualify.

Section 4. Notice is hereby given that Henry V. Bonner, Mayor, will be a candidate for re-election as Mayor of the City of Roanoke, Roanoke, Alabama; and the Mayor hereby appoints Judy R. Young, City Clerk, to perform all duties necessary for said election to be held on Tuesday, August 23, 1988, and at a runoff election if necessary to be held on Tuesday, September 13, 1988.

Section 5. That all Ordinances or parts of Ordinances in conflict herewith or previously in effect are hereby repealed.
