ORDINANCE NO. 552

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENCE "A" DISTRICT AND RESIDENCE "C" DISTRICT TO GENERAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, Alabama, and the Zoning Map of the City of Roanoke, Alabama, be amended, altered and changed to rezone and reclassify in the

manner hereinafter provided the following described property
located in the City of Roanoke, Randolph County, Alabama, to-wit:

That certain somewhat triangular-shaped tract or parcel of land bounded on the Easterly side by U. S. Highway 431 (Roanoke By-Pass); on the Northerly side by Alabama Highway 22 or Rock Mills Road and by the Raymond Landers residence property; on the Westerly or Northwesterly side by property of J. H. Allen and by Tally Street (including any alleyways formerly a part of Tally Street); and on the Southwesterly or Southerly side by Cook Road.

Section 2. That that portion of the above described property presently zoned or classified Residence "A" District and that portion of the above described property presently zoned or classified Residence "C" District be rezoned and reclassified to General Business District; and that from and after the passage and adoption of this Ordinance, the property described in Section 1 above shall be classified as General Business District property and shall be subject to the uses, regulations and restrictions as to General Business District property as set forth in the Zoning Ordinance of the City of Roanoke, Alabama, as the same may be now or hereafter amended.

Section 3. All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 4. This Ordinance shall be in force and effect upon its passage and adoption as provided by law.

CITY TAX ORDINANCE

NO. 553

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1, 1976.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

SECTION 1. That taxes are hereby levied for the City of Roanoke, Alabama, on all real and personal property and other properties and franchises located or taxable in the City of Roanoke, Alabama, for the year 1976, based upon the valuation as assessed for state taxation during last year, as follows:
