## ORDINANCE NO. 568

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA FROM RESIDENCE "A" DISTRICT, RESIDENCE "B" DISTRICT AND RESIDENCE 'C" DISTRICT TO GENERAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, Alabama, and the Aoning Map of the City of Roanoke, Alabama, be amended, altered and changed to rezone and reclassify in the manner hereinafter provided the following described property located in the City of Roanoke, Randolph County, Alabama, to-wit;

All land lying and being along and on either side of the right-of-way of U.S. Highway 431, known as The Roanoke By-Pass, and extending back from each right-of-way line a distance of four hundred (400) feet in each direction, and being further described as strips

of land each four hundred (400) feet in uniform width on either side of said right-of-way line of said U.S. Highway 431, or Roanoke By-Pass, from the present South boundary of the City of Roanoke, Alabama, or City Limits, to the present North boundary of the City of Roanoke, Alabama, or City Limits.

Section 2. That that portion of the above described property presently zoned or classified Residence "A" District and that portion of the above described property presently zoned or classified Residence "B" District and that portion of the above described property presently zoned or classified Residence "C" District be rezoned and reclassified to General Business District; and that from and after the passage and adoption of this Ordinance, the property described in Section 1 above shall be classified as General Business District property and shall be subject to the uses, regulations and restrictions as to General Business District property as set forth in the Zoning Ordinance of the City of Roanoke, Alabama, as the same may be now or hereafter amended.

Section 3. All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 4. This Ordinance shall be in force and effect upon its passage and adoption as provided by law.

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA, FROM RESIDENCE "C" DISTRICT TO GENERAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, Alabama, be amended, altered, and changed to rezone or reclassify from Residence "C" District to General Business District the Following described property situated in the City of Roanoke, Randolph County, Alabama, to-wit:
