## ORDINANCE NO. 569

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROANOKE, ALABAMA AND THE ZONING MAP OF ROANOKE, ALABAMA TO REZONE OR RECLASSIFY CERTAIN PROPERTY IN THE CITY OF ROANOKE, ALABAMA, FROM RESIDENCE "C" DISTRICT TO GENERAL BUSINESS DISTRICT, AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, AS FOLLOWS:

Section 1. That the Zoning Ordinance of the City of Roanoke, Alabama, be amended, altered, and changed to rezone or reclassify from Residence "C" District to General Business District the Following described property situated in the City of Roanoke, Randolph County, Alabama, to-wit:

A piece, parcel, or tract of land just outside the City of Roanoke, moreparticularly described as follows: Begin at a concrete R.O.W. marker on the East R.O.W. line of U.S.. 431, said R.O.W. marker being located 140 from and at right angles to the Centerline of U.S. 431 at Station 951+53; thence S 82°-06 E, a distance of 125 feet; thence S 16°-28' W a distance of 200 feet; thence N 82°-06' W a distance of 119 feet to the East R.O.W. line of U.S. 431; thence N 7°-40' E a distance of 47 feet to a concrete R.O.W. marker at Station 950+00; thence N 15°-11' E a distance

of 153 feet to the point of beginning.

The above described property situated, lying and being in Section 1, T-22-S, R-12-E in Randolph County, Alabama.

Section 2. From and after thepassage and adoption of this Ordinance, the property described in Section 1 above shall be classified as General Business District property and shall be subject to the uses, regulations and restrictions as to General Business District property as set forth in the Zoning Ordinance of the City of Roanoke, Alabama, as the same may be now or hereafter amended.

SEction 3. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 4. This Ordinance shall be in force and effect upon its passage and adoption as provided by law.
