

regulating the use of the streets of the City, and the acceptance by the Company of this ordinance shall be an agreement by it to pay to the City any sum of money for which the City may become liable from or by reason of such injury.

SECTION 5. The Company shall file with the City Clerk of the City its acceptance of this ordinance within sixty days from the date when it shall take effect.

SECTION 6. Nothing in this ordinance shall be construed as a surrender by the City of its right or power to pass ordinances regulating the use of its streets.

SECTION 7. This ordinance shall be in force from and after the date of its passage and publication as required by law.

CITY TAX ORDINANCE

No. 456

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1, 1958.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

SECTION 1: That taxes are hereby levied for the City of Roanoke, Alabama, on all real and personal property and other

properties and franchises located or taxable in the City of Roanoke, Alabama, for the year 1958, based upon the valuation as assessed for state taxation during last year, as follows:

- 1. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation to be applied exclusively to the payment of bonds heretofore issued and the interest thereon.
- 2. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for general municipal purposes.
