 CITY TAX ORDINANCE

No. 467

TO LEVY TAXES FOR THE CITY TAX YEAR COMMENCING OCTOBER 1, 1961.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA, as follows:

SECTION 1: That taxes are hereby levied for the City of Roanoke, Alabama, on all real and personal property and other properties and franchises located or taxable in the City of Roanoke, Alabama, for the year 1961, based upon the valuation as assessed for state taxation during last year, as follows:

1. A Tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation to be applied exclusively to the payment of bonds heretofore issued and the interest thereon.
2. A tax of one-half of one per centum, or fifty cents on each One Hundred Dollars valuation for general municipal purposes.

AN ORDINANCE

No. 468

SECTION 1.

As used in this ordinance the term Civil Defense shall include measures for the mobilization, organization and direction of the civilian population and necessary support agencies to prevent, or minimize, the effects of fire, flood, earthquake and epidemic, as well as the effects of a nuclear war, or any subversive activities against the populace, communities, industrial plants, facilities and other installations.

SECTION 11 - POWER AND DUTIES

It shall be the duty of the Roanoke Civil Defense organization, and it is hereby empowered:

- A. To develop a Municipal Civil Defense Operational Survival Plan. This plan shall provide for the effective mobilization of all resources of the municipality, both private and public.
- B. To prepare and recommend for consideration by the Council ordinances necessary to implement
