ORDINANCE NUMBER 695

AN ORDINANCE SUPERSEDING AND REPLACING ORDINANCE 543 PROVIDING SCHEDULE OF LICENSES FOR THE CITY OF ROANOKE, ALABAMA, AND THE POLICE JURISDICTION THEREOF, FOR THE YEAR BEGINNING JANUARY 1, 1995, AND ENDING DECEMBER 31, 1995 AND FOR EACH SUCCEEDING YEAR THEREAFTER, FOR THE PRIVILEGE OF ENGAGING IN THE DIVERSE DESIGNATED BUSINESSES, PROSCRIBING THE AMOUNTS AND THE MANNER AND TIME FOR THE PAYMENT OF SUCH LICENSES, PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE, AND OTHER MATTERS RELATING THERETO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA AS FOLLOWS:

SECTION 1. DEFINITIONS. Unless the context clearly indicated a different meaning, the following words and phrases, wherever used in this ordinance, shall have the meanings respectively ascribed to them in this section:

"City" means the City of Roanoke, Alabama.

"Police Jurisdiction" means all that territory outside the corporate limits of the City but within three miles of the corporate limits of the City.

"Person" means and includes each and every individual, firm, corporation, person, association, company, partnership, or agency.

"Business" means and includes each and every exhibition, activity, trade, business, vocation, occupation, profession, machine, device, article or line of merchandise, engaged in, conducted, carried on, or operated in the City, or the police jurisdiction thereof, for which a license is required and provided for hereunder.

Wherever the context requires, the masculine gender shall include the feminine and neuter genders, and the plural shall include the singular and the singular shall include the plural.

LICENSE SCHEDULE. SECTION 2. The following is hereby adopted and declared to be the schedule of licenses for the year beginning January 1, 1995, and ending December 31, 1995 and for each successive calendar year thereafter, except to the extent that the same may be hereafter amended or repealed. Each person engaging in, conducting, carrying on or operating any business for which a license is hereinafter designated and specified within the corporate limits of the City is required to obtain from the City an annual privilege license (except in those situations where a license for a shorter period than the calendar year is hereinafter provided for, in which event the license for such shorter period shall be obtained from the City), and each such person shall pay the City Therefor the amounts hereinafter specified for each such business, except as may be otherwise expressly hereinafter provided for, which said licenses shall be issued by the City Clerk upon payment to the City Clerk of the full amounts, including also

issuance fees and penalties, if any, as is specified, designated and provided for hereinafter. In addition to the license schedule hereinafter set forth in this section, there is included herein as a part of said schedule the Index appearing at the end of this ordinance.

SCHEDULE

1. <u>ADVERTISING</u> - Each person engaged in the business of advertising, by whatever means, shall pay a license tax as follows:

In addition to the above base license tax, each person so engaged shall pay an amount equal to 1/15 of one percent (1%) of the gross receipts derived from such businesses in excess of \$20,000.000

- 2. AGENTS Each person taking orders for any articles or merchandise or services and/or delivering same in person or by another shall pay the same license as he would pay if licensed in the City as a regular resident business, profession, vocation, or calling. This section does not include employees of properly licensed businesses.
- 3. <u>AUCTIONS</u> Each person holding an auction of any real or personal property within the corporate limits of the City of Roanoke shall pay a license tax as follows:

Antique carpets or rugs - per week	375.00

This license shall be in addition to the license provided by any other schedule of this Ordinance, except that in no case shall this license apply to judicial sales or sales by executors or administrators, nor to sales by or in behalf of licenses pawnbrokers of unredeemed pledges in a manner provided by law.

4. <u>AUTOMOBILE DEALERS</u>. Each person engaged in the business of buying, selling, or trading new or used trucks, automobiles, mobile homes, industrial and farm tractors, and equipment or aircraft, shall pay a license tax based on gross annual receipts as follows:

On less than \$200,000.00

187.50

plus an additional amount equal to 1/30 of one percent (1%) of all gross receipts over \$200,000.00.

For the purpose of this schedule, gross receipts shall mean the entire receipts of the business including all receipts from government sales, sales outside the City of Roanoke, parts department, connecting garages, shops, services, etc., that form an integral part of the "dealership".

Deductions from gross receipts may be taken for used vehicles taken in trade as credit or part payment on the ale of a new or used vehicle; Dealer transfers and internal parts. A deduction from gross receipts may also be taken for repossessions of vehicles, such deduction being based on the unpaid purchase price remaining at the time of repossession.

Each person engaged in the business of buying, selling, or trading, used trucks or automobiles only, shall pay \$187.50 plus a percentage of gross receipts as required above.

5. <u>AUTOMOBILE OR TRUCK RENTAL</u>. Each person engaged in the business of rental or leasing automobile or trucks shall pay a license tax as follows:

For each automobile or truck

For each automobile or truck rented by contract specifying the rental of five (5) or more vehicles on a fleet basis for a period of twelve (12) months or more.

This schedule does not apply to the rental or lease of aircraft which business should be licensed under Schedule 4 of this Ordinance and which licenses should be computed on a gross receipt basis as provided in Schedule 4.

6. BANKRUPT AND FIRE SALES. Each person, other than the original bona fide owner, selling goods, wares, or merchandise as an agent, receiver or otherwise obtaining rights to the property for sales as a close-out, fire, water, or smoke damage shall pay a license tax of \$

375.00

No license shall be issued under this section for less than a full year.

7. BARBER SHOP - BEAUTY SHOP. Each person operating a barber shop or beauty shop shall pay a license tax in accordance with the number of chairs of beauty operators therein as follows:

For one barber chair or beauty operator \$ 22.50 For each additional barber chair/beauty operator 11.25

8. <u>BILLIARD OR POOL ROOMS</u>. Each billiard or pool room or parlor shall pay an annual license tax for the first table of

For each additional table

75.00

This license is required for all tables whether in use or not.

9. BONDS - APPEARANCE AND APPEAL. Each person engaged in the business of becoming or procuring surety for any court, appeal appearances or otherwise for a consideration, except guaranty companies or corporations otherwise specifically licensed, shall pay a license tax based on his gross annual receipts as follows:

One less than \$125,000.00

187.50

Plus an additional amount equal to 1/15 of one percent (1%) of all gross receipts in excess of \$125,000.00.

- 10. BOOTBLACKS. Each person engaged in shining or polishing shoes or boots shall pay for each chair, whether in connection with other business or not, an annual license tax of \$ 11.25
- 11. BOWLING ALLEY. Each person engaged in the business of providing bowling alleys, including ten pin alleys, box ball alleys, shuffle boards and miniature bowling alleys and shuffle boards, shall pay a license tax as follows:

12. BROKER OR DEALERS IN SECURITIES. Each person engaged in the business of acting as broker or dealing in securities, commodities, or mutual funds, or in the business of lending money on said stocks, bonds, securities, or commodities, shall pay an annual license tax based on his gross annual receipts as follows:

On less than \$25,000.00

150.00

150.00

Plus an additional amount equal to 1/30 of one percent (1%) of all gross receipts in excess of \$25,000.00.

COTTON DEALERS OR BROKERS. Each cotton buyer, broker, agent, or branch office maintaining an office and executing future contracts on any cotton exchange, for the general public, which shall include the right to buy and sell cotton \$

Plus an amount equal to \$75.00 for each 5,000 bales, or a fraction thereof, in excess of 15,000 bales volume.

BUILDING AND LOAN OR SAVINGS AND LOAN ASSOCIATIONS OR BANKS.

Each person operating a building and loan association, savings and loan association, or bank shall pay an annual license tax as follows:

14. CARNIVAL, FAIR OR CIRCUS. Each person operating a carnival, fair, circus, or similar activity shall pay a license tax as follows:

Circus - per day \$ 150.00

Carnival or Fair - per week 300.00

- 15. <u>CEMETERY COMPANIES.</u> Each person engaged in the business of selling, soliciting the sale, or of furnishing cemetery lots shall pay a license tax of \$ 75.00
- 16. CONTRACTORS BUILDING. Each person engaged in the business of accepting orders, contracts, or subcontracts for erecting, enlarging, improving, relocating any building or structure, or making improvements to the land (including, but not limited to building, grading, paving, installation of curbs, gutters or sewers, excavating, landscaping, roads, bridges, or utilities construction) or any other type of construction shall pay a license tax based on his gross annual receipts from contracts performed within the City of Roanoke and its police jurisdiction as follows:

Less than \$10,000.00 \$ 37.50 \$10,000.00 & less than \$25,000.00 75.00 \$25,000.00 & less than \$100,000.00 150.00

And, in addition, 1/15 of one percent (1%) on all gross receipts in excess of \$100,000.00 but less than \$500,000.00 plus 1/30 of one percent (1%) of gross receipts in excess of \$500,000.00 but less than \$5,000,000.00, plus 1/80 of one percent (1%) in excess of \$5,000,000.00.

17. CONTRACTORS AND SUBCONTRACTORS. Engineering, Research, and Manufacturing - Each person, firm or corporation engaged in the business of accepting orders, contracts, or subcontracts for engineering, research or manufacturing of a product developed by the engineering or research services shall pay a license tax based on gross receipts from contracts performed within the City of Roanoke and its police jurisdiction as follows:

On gross receipts; same as above in Schedule 16.

18. <u>DELIVERY.</u> Each person delivering articles of merchandise or any other property within the City when no in connection with a regularly licensed business shall pay a license tax for each vehicle delivering merchandise within the City of

Persons taking orders, soliciting or consummating sales of merchandise or taking orders, soliciting or consummating sales of services or performing such services within the City of Roanoke or its police jurisdiction shall obtain a license based on such business, profession, or vocation, which shall entitle such business to deliver within the City without obtaining additional license.

This license receipt should be affixed to the vehicle at the time of receipt and shall not be transferable from one vehicle to another.

19. <u>DEVELOPMENT OF PROPERTY.</u> Each person engaged in the business of developing, subdividing, and selling lots to builders or others shall pay an annual license tax of

75.00

Plus an amount equal to 1/15 of one percent (1%) of gross receipts for the preceding year in excess of \$50,000.00.

20. <u>DIRECTORY</u>. Each person making, compiling, selling, or offering for sale any directory shall pay a license tax of

225.00

Said license shall also entitle such person to sell advertising in said directory without procuring additional license therefor.

- 21. ENTERTAINMENT. Each person, other than religious, charitable, or educational organizations, engaged in any type of entertainment, not otherwise provided for, including but not limited to boxing, wrestling, rodeos, sports events, races, museums, lectures, concerts, or other shows or performances where charges are made for admission shall pay a license tax per week of
- 22. EXPRESS COMPANIES. Each railway express company, for the privilege of doing business within the corporate limits of the City \$ 112.50
- 23. EXTERMINATORS. Each person selling disinfectant insecticide, and/or exterminators engaged in the business of pest extermination in any manner shall pay an amount equal to 1/6 of one percent (1%) of gross annual receipts with a minimum license tax of \$ 112.50
- 24. <u>FINANCE AND LOAN COMPANIES</u>. Each person engaged in the business of lending money or discounting or buying conditional sales contracts, drafts, acceptances, notes or mortgages shall pay an annual license tax on the following basis:

When the total amount in additional to principal customarily paid by the borrower including interest, investigation fees, service charge and every other item of expense of every kind does not exceed one percent (1%) per month \$ 150.00

When the total amount in addition to principal customarily paid by the borrower including interest, investigation fees, service charge and every other item of expense of every kind exceeds one percent (1%) per month \$ 300.00

25. <u>FUNERAL DIRECTORS</u>. Each person engaged in business as funeral director, undertaker, or mortician shall pay an annual license tax based on gross receipts as follows:

On gross receipts of less than \$50,000.00 \$ 150.00

Plus an additional amount equal to 1/15 of one percent (1%) on all gross receipts in excess of \$50,000.00. The foregoing license tax shall include embalming, the sales of caskets, vaults, undertaking supplies, and the operation of ambulances and hearses where the gross receipts from such sales and services are included in computing this license.

26. <u>GASOLINE</u>. Each person engaged in the business of selling gasoline at retail or operating a gasoline filling station shall pay a license tax as follows:

First double or more hose pump \$	30.00
Each additional double or more hose pump	15.00
First double hose pump	45.00
Each additional double hose pump	22.50
Tank trucks for delivering to airplanes-each truck	37.50

This license shall include sales of kerosene, but not the sale of other merchandise such as tires, batteries, accessories, etc., for which a merchant-retail license must be paid. Gross receipts from sales of gasoline should not be included in the computation of any other license required.

Each person engaged in the business of selling gasoline or other petroleum products at wholesale or delivering gasoline within the City of Roanoke, or its police jurisdiction, shall pay a license tax based on the number of gallons sold or delivered within the City of Roanoke, or its police jurisdiction, as follows:

On less than 1,000,000 gallons	\$ 187.50
1,000,000 & less than 2,000,000 gallons	225.00
2,000,000 gallons and over	300.00

27. GOLF. Each person engaged in the operation of a golf course, driving range, miniature golf, or similar activity shall pay an annual license tax of \$75.00

28. <u>HOSPITAL AND/OR CLINIC.</u> Each person operating a hospital, clinic, rest home or sanitorium for profit shall pay a license tax as follows:

Hospital or clinic:
Five beds or less \$ 150.00
Each additional bed 7.50

29. <u>HOTELS AND MOTELS</u>. Any person engaged in the hotel, motel, or similar business shall pay an annual license as follows:

First 15 rooms
Each additional room

\$ 75.00 7.50

This license does not include the right to operate a restaurant, barber shop, cigar or newsstand, or any other secondary business operated in connection with the renting of rooms without additional license.

- INSURANCE. (a) Fire or Marine Insurance For the privilege 30. of engaging in fire or marine insurance business, each company doing business in the City shall pay a license to the City equal to six percent (6%) of each \$100.00, or major fraction thereof, of the gross premiums, less return premiums, on policies issued during the preceding year on property located in the City. Provided, that if the company has done no fire or marine insurance business in the City the preceding year, there is hereby levied and assessed a license fee of \$37.50, payable at the time and in the manner prescribed for other license under this ordinance, and at the expiration of the calendar year for which such license is issued, or within 60 days thereafter, the company shall furnish the Mayor of the City a written statement, verified by the affidavit of the president, vice president, or secretary of the company, setting out the full and true amount of the gross premiums less return premiums on fire or marine policies issued during the year for which the license was issued on property located in the City, which statement shall be accompanied by the additional amount of license due the City which additional amount is to be computed by taking six percent (6%) of each \$100.00 or major fraction thereof of such gross premiums, less return premiums, and deducting therefrom the amount of the license previously paid, so that the total amount of license paid the City shall equal six percent (6%) of each \$100.00, or major fraction thereof of the gross premiums, less return premiums on policies issued during the year for which the license was issued on property located in the City. event the \$37.50 license previously paid by the company exceeds the amount owed the City, computed as set forth hereinabove, the City shall refund to the licensee the amount due it when such verified statement is filed.
 - (b) Insurance Other Than Fire or Marine For the privilege of engaging in life insurance business, or any kind of insurance other than fire or marine, each company engaging in such business or its agents shall pay a license to the City of \$22.50 and in addition thereto, an amount equal to \$1.50 on each \$100.00, or major faction thereof, of the gross premiums

less return premiums received during the preceding year on policies issued during said year to citizens of the City. Upon payment or tender of said sum of \$22.50 to the City at the time and in the manner prescribed for other licenses under this ordinance, such insurance company shall be permitted to do business in the City, through its agents.

- (c) On the first day of January of each year, or within 60 days thereafter, each insurance company mentioned in (a) and (b) above, which did any business in the City during any part of the preceding year shall furnish the Mayor of the City a statement in writing, verified by the affidavit of the president, vice present, or secretary of the company, showing the full and true amount of gross premiums, less return premiums, received during the preceding year on policies issued during such year, which policies are described in (a) and (b) above, and each insurance company shall accompany such statement with the amount of license tax due, according to the provisions herein set forth.
- (d) Upon a failure to any insurance company to furnish any statement or to pay the license prescribed, in the time, manner, or amount set forth and provided for in this Schedule 30, there shall be a forfeiture of the right of such company so failing, and its agents, to continue to do business in the City until such statement shall have been furnished and such sum shall have been paid in full, and such company and its agents doing business in the City pending such forfeiture shall be guilty of a misdemeanor against the City and shall be punished as though it or they were doing business without a license, as is provided without the limits of the punishment prescribed in Section Seven of this ordinance.
- 31. KENNELS AND/OR VETERINARY HOSPITALS. Each person operating a veterinary hospital or kennel, including each person and each member of a firm or partnership engaged in the practice of veterinary medicine shall pay, for the operation thereof, a license tax based on his gross annual receipts as follows:

On less than \$5,000.00	\$ 37.50
\$5,000.00 & less than \$10,000.00	52.50
\$10,000.00 & less than \$25,000.00	75.00
\$25,000.00 & less than \$50,000.00	112.50

plus an additional amount equal to 1/30 of one percent (1%) of all gross receipts in excess of \$50,000.00.

32. <u>LAUNDRY AND/OR DRY CLEANERS</u>. Any person operating a laundry, dry cleaners, linen supply service, or diaper service shall pay an annual license tax of \$ 150.00

Dry Cleaning Only

and, in addition, 1/15 of one percent (1%) of gross annual receipts in excess of \$50,000.00 from said business. In addition to the license provided above, each branch or place of business for the purpose of collecting laundry or dry cleaning shall pay an annual license of

33. <u>LAUNDRIES</u>, <u>SELF-SERVICE</u>. Each person operating any self-service laundry or renting washing machines, dryers, or dry cleaning machines shall pay an annual license tax for each machine as follows:

First ten (10) machines For each subsequent machine \$ 75.00 5.00

34. MANUFACTURERS. Each person engaged in the business of manufacturing, producing, fabricating, or processing, not otherwise specifically licensed, shall pay a license tax based on his gross annual receipts as follows:

On gross receipts of \$50,000.00 or less \$50,000.00 & less than \$100,000.00 150.00 300.00

and, in addition, 1/30 of one percent (1%) of all gross receipts in excess of \$100,000.00 and not over \$1,000,000.00; and 1/60 of one percent (1%) on all gross receipts exceeding \$1,000,000.00 and not over \$10,000,000.00; and 1/140 of one percent (1%) of all gross receipts exceeding \$10,000,000.00.

For the purpose of this schedule gross receipts shall mean the entire receipts of the business including all gross receipts from government sales, sales outside the City of Roanoke and inter-company book transfers. (Thus meaning the volume or value of the plant's transferred products regardless of whether transferred to another plant or affiliated company, or sold or manufactured under contract.)

35. MEDIUMS. Each medium, fortune teller, palmist, clairvoyant, crystal gazer, divine healer, spiritual reader, or similar profession, whether or not any fee is charged directly or indirectly or whether or not any gratuity is accepted shall pay a license tax per week of

36. MERCHANTS - RETAIL. Each person engaged in selling goods, wares, products, or services (not specifically provided for in this license schedule) to others for consumption or use shall pay a license tax based on his gross annual receipts as follows:

On less than \$10,000.00 \$10,000.00 & less than \$20,000.00 37.50 75.00 Plus and additional amount equal to 1/15 of one percent (1%) of gross receipts over \$20,000.00 and not over \$500,000.00; and 1/30 of one percent (1%) of gross receipts exceeding \$500,000.00.

37. MERCHANTS - WHOLESALE. Each person engaged in selling goods, wares, products, or services (not specifically provided for in this license schedule) to others for resale and who is entitled to Merchants - Wholesale rates as defined in Section Fifteen of this ordinance shall pay a license tax based on his gross receipts as follows:

On less than \$25,000.00	\$ 75.00
\$25,000.00 & less than \$50,000.00	150.00
\$50,000.00 & less than \$100,000.00	225.00
\$100,000.00 & less than \$150,000.00	300.00
\$150,000.00 & less than \$250,000.00	375.00

and, in addition, 1/30 of one percent (1%) of gross receipts in excess of \$250,000.00.

38. MISCELLANEOUS. Each person, dealer, association, or other business who shall in any capacity engage in or transact any trade, business, commerce, occupation, vocation, or profession for which no other license is specifically required by this ordinance shall pay an annual license tax of \$ 37.50

plus and additional amount equal to 1/15 of one percent (1%) of annual gross receipts over \$10,000.00.

- 39. MOTOR TRANSPORTATION. (a) any motor bus terminal, or any person, firm, or corporation operating any terminal or station facilities for transportation by motor carrier, of passengers, property or express \$ 150.00
 - (b) Any motor carrier as defined by Article 3 of the "Alabama Motor Carrier Act of 1939" (Title 48, Section 301(1), et seq., Code of Alabama), for the privilege of doing business in the City by receiving passengers or freight for transportation for hire between the City and other points in Alabama \$ 150.00
- 40. NEWSPAPERS. Each person publishing or distributing newspapers of less than four (4) issues per week shall pay an annual license tax of \$ 112.50

Plus an amount equal to 1/15 of one percent (1%) of the gross receipts in excess of \$50,000.00 as described above.

Each person distributing or delivering newspapers published outside the City of Roanoke or its police jurisdiction shall pay an annual license tax of \$ 30.00

41. PARKING LOTS. Each person engaged in the business of storing or parking automobiles or other vehicles shall pay a license tax as follows:

Where space for note more than twenty-five (25) automobiles or vehicles is provided \$ 37.50

Plus \$3.00 for each additional space provided over 25.

42. PAWN BROKER. Each person engaged in business as a pawn broker shall pay an annual license tax of \$ 225.00

Plus an amount equal to that required of a retail merchant on gross receipts from sales or merchandise, as provided in Schedule 36 of this license schedule.

43. PISTOLS AND/OR OTHER WEAPONS. Each dealer in guns, pistols, revolvers, explosives, bowie knives, dirks, or other weapons, whether in connection with other business or not, shall pay an annual license tax of \$

37.50

Plus such additional amount as will equal 1/15 of one percent (1%) of the total gross receipts from such sales.

- 44. PREMIUM STORE. Each person engaging in or operating a premium redemption store where trading stamps are redeemable for premiums or things of value shall pay a license tax based on the gross retail value of premiums delivered in redemption of such stamps under the Merchants-Retail schedule of rates, as provided in Schedule 36 of this license schedule.
- 45. PROFESSIONS AND VOCATIONS. Each person and each member of a firm or partnership engaged in any practice, vocation or profession shall pay a license tax based on his gross annual receipts as follows:

On less than	\$10,000.00	\$ 56.25
\$10,000.00 &	less than \$25,000.00	75.00
\$25,000.00 &	less than \$35,000.00	112.50
\$35,000.00 &	less than \$50,000.00	150.00

Plus an additional amount equal to 1/15 of one percent (1%) of gross receipts above \$50,000.00

Where the licensed entity is a partnership, the gross receipts of each partner will be determined according to the partnership agreement by allocating to each partner gross receipts in the same proportion as the profits distributed to said partner. Where the entity licensed is a corporation, the

._ -. : :

records and accounts of the corporation shall be so kept as to show the percentage of the business actually owned by each professional practitioner, and the license of each practitioner shall be determined according to his percentage of ownership. In the event the books, records and accounts of the licensed entity are not kept so as to show the interest of each professional practitioner, then each practitioner shall be deemed to have gross receipts requiring the maximum license payment under this schedule.

In addition to the above licenses, the employer shall pay \$30.00 on each <u>professional</u> salaried employee.

Companies, firms or corporations who are primarily performing such services as are described in Schedule 17 of this license schedule shall be exempt from this license if a Contractors and Subcontractors - Engineering, Research and Manufacturing license is lawfully obtained by such company, firm or corporation.

- 46. PUBLIC UTILITIES. Each person engaged in the operation of a public utility (except telephone and telegraph companies, railways and sleeping car companies, express companies and City public municipal boards) furnishing, supplying, or selling public utility service such as water, gas, light, or power shall pay an annual license tax of three percent (3%) of the gross receipts of the business done by the utility in the City during the preceding year.
- 47. RADIO AND TELEVISION BROADCASTING STATIONS. Each person who solicits advertising for radio or television broadcasting stations or companies shall pay an annual license tax based on his gross annual receipts as follows:

On less than \$50,000.00

Plus an additional amount equal to 1/15 of one percent (1%) of gross receipts in excess of \$50,000.00.

Provided, that this license shall not apply to that portion of the business that may be in interstate or foreign commerce or to business with the government of the United States.

- 48. RAILROADS. For operating a railroad within this state as common carrier, for the privilege of doing intrastate business within the City \$ 150.00
- 49. REAL ESTATE AGENTS, BROKERS, OR DEALERS. Each person whether as principal or agent, engaged in the business of buying, selling, or exchanging real estate on commission shall pay a license tax based on his gross receipts as follows:

On less than \$5,000.00 \$5,000.00 & less than \$10,000.00

50. RENTING AND/OR LEASING. Each person engaged in the business of renting or leasing real or personal property to others, including but not limited to apartments, office space, buildings, houses, office furniture and equipment, shall pay a license tax based on gross receipts as follows:

On more than \$5,000.00 & less than \$10,000.00 \$ 37.

Plus an additional amount equal to 1/15 of one percent (1%) of all gross receipts over \$10,000.00 but less than \$100,000.00, and 1/30 of one percent (1%) of gross receipts in excess of \$100,000.00

51. REPAIRS AND SERVICES. Each person engaged in the business of repairing, installing, improving, or servicing property which belongs to others, or performs any other service not regarded as a profession or vocation, shall pay an annual license tax based on gross annual receipts as follows:

53. SCHOOLS. Each person conducting a school or college as a business for profit shall pay a license tax for the privilege of engaging in such business as follows:

54. SHOOTING GALLERY. Each person operating a shooting gallery shall pay an annual license tax of \$ 150.00

- (b) For the operation of long distance of telephone lines in t his State, for the privilege of doing intrastate business within the limits of Roanoke by providing long distance connection between this and other points in Alabama \$ 79.50
- 60. <u>TELEVISION DISTRIBUTION.</u> Each person conducting or engaging in the business of cable television distribution shall pay a license tax of \$ 150.00

Plus such additional amount as will equal three percent (3%) of the total gross receipts from said business during the next preceding year.

Provided, however, that no person shall engage in or be licensed to operate a television distribution system without first having secured a franchise for same from the City of Roanoke.

61. THEATERS OR MOTION PICTURE SHOWS. Each person operating a theater, motion or moving picture show, or theatrical theater where general admission is charged shall pay an annual license of \$ 75.00

Each person engaged in the business of issuing, selling, or leasing to merchants or others trading stamps, registration cards, coupons, certificates, or anything of like character, which are redeemable or which will be accepted in full or partial payment or in exchange for anything of value shall pay an annual license tax of \$ 112.50

67. WHOLESALE GROCERY AND DRUG SALES. Each person engaged in selling groceries, meats, or drugs to others for resale shall pay a license tax based on his gross receipts from sales within the City of Roanoke and its police jurisdiction as follows:

On less than \$100,000.00 \$ 150.00 \$100,000.00 & less than \$150,000.00 225.00 \$150,000.00 & less than \$200,000.00 300.00

and in addition 1/15 of one percent (1%) of each gross receipts in excess of \$200,000.00

68. TRANSIENT RETAIL SALES. Each person engaged in retail sales without an approved established business location in the City shall pay an annual license fee of \$ 200.00

This license provision shall not apply to persons selling agricultural crops that the persons have grown themselves.

SECTION 3. LICENSE PERIOD. Except as otherwise specifically provided, all licenses imposed by this ordinance shall be annual licenses, beginning on the first day of january of each year and ending on the thirty-first (31st) day of December of each year. No license shall be issued except for the full period provided for in the license schedule, provided that where the license is an annual license and the business is begun on or after July 1st of the calendar year, the license shall be issued at one-half (1/2) the amount prescribed for the annual license.

SECTION 4. DUE DATE AND PENALTY. Except as otherwise specifically provided, where an annual license is required and the business is being engaged in on January first of any calendar year, the license shall be due and payable on January first and shall become delinquent if not paid by February first of that year. Where the business is begun after January first but prior to July first, the license shall be due and payable at the commencement of the business and shall become delinquent if not paid within thirty (30) days after the commencement of business. Where the business is begun on or after July first of the calendar year so as to entitle the licensee to a license at one-half (1/2) the amount of the annual license, such license shall be due and payable at the commencement of the business and shall become delinquent if not paid within ten (10) days after commencement of the business. the case of daily, weekly or monthly licenses, such licenses must be paid for prior to beginning the business and the same shall be delinquent if not so paid for and obtained prior to the commencement of the business. If any licenses is not paid and

obtained within the time specified in this ordinance, the same shall become delinquent, in which event there shall be added to the amount of the license an additional license equal to ten percent (10%) of the amount of the license as a penalty for allowing the license to become delinquent.

SECTION 5. UNLAWFUL TO DO BUSINESS WITHOUT A LICENSE. It shall be unlawful and shall constitute a misdemeanor against the City for any person, or the agent, servant, or employee of such person, to engage in, conduct, carry on or operate any business for which a license is required herein without the license having been paid for and obtained from the City prior to the time and same becomes delinquent, as provided in this ordinance, and any violation of this section shall be punishable by a fine of not exceeding Two Hundred Dollars (\$200.00), and by imprisonment or hard labor for the City not exceeding six months, one or both.

SECTION 6. LICENSE FOR EACH BUSINESS. Any person engaging in, conducting, carrying on or operating more than one business for which licenses are required by this ordinance shall obtain and pay for a license for each such business for which a license is required, unless otherwise expressly designated and provided for in this ordinance.

SECTION 7. ISSUANCE OF LICENSE. The City Clerk of the City of Roanoke, Alabama, shall issue the licenses provided for and required under this ordinance, upon compliance with the provisions hereof, and full payment for the same, including also issuance fees and any penalty for delinquency which might be due, shall be made to the City Clerk before any license shall be issued.

SECTION 8. LICENSE DESIGNATES PLACE OF BUSINESS. Any person engaging in, conducting, carrying on or operating any business for which a license is required by this ordinance shall designate the place at which such business will be engaged in, conducted, carried on or operated, and the license shall designate such place, and such license shall authorize the carrying on of such business only at the place designated, but if the place of business be moved during the license period, the licensee shall present the license to the City Clerk who shall endorse thereon the new location of the business, and for the remaining time of the license period no new license shall be required for engaging in the business at the new location. Provided, however, no license issued hereunder may be transferred from one person to another, nor from one business to another.

SECTION 9. POSTING OF LICENSE. Each license issued hereunder shall be posted in a conspicuous place at the place where the licensee is doing business thereunder, and if the licensee has no fixed place of business it shall be carried on the licensee's person or be kept in a readily accessible place, and all licenses issued hereunder shall be immediately exhibited to any license inspector of the City or to any police officer of the City upon demand of such license inspector or police officer.

SECTION 10. SWORN STATEMENT. In all cases where the amount of the license is dependent upon the amount of business done, gross receipts, value of stock or equipment, number of employees, or any other factors, it shall be the duty of the person subject to such license to render to the City Clerk a sworn statement showing the relevant information needed for proper classification of such person for license purposes and for ascertainment of the correct amount of license tax to which he is subject. After receipt of such sworn statement of the amount of license shown to be due by such statement, the City Clerk shall issue the appropriate license, but the issuance thereof is expressly subject to and conditional upon the truth and accuracy of such sworn statement and the license shall be revocable by the City Council as mistakenly issued whenever it shall be made to satisfactorily appear to the City Council that the sworn statement is false or incorrect or that the holder of the license has not paid to the City the correct amount of license tax.

SECTION 11. GROSS RECEIPTS. Where the amount of the license is based upon gross receipts, the term "gross receipts", unless the contrary clearly appears, shall mean the entire receipts of the business, profession, vocation or occupation engaged in, including also all receipts from sales regardless of the place where the sale was solicited, or place where the contract of sale was consummated, or the place of delivery, and shall include the amount of federal excise tax, and shall not contemplate any deductions for any purpose not specifically provided for in this ordinance or otherwise required by law. Unless otherwise indicated, the gross receipts or gross sales referred to are those for the year next preceding the then current license year. Provided, however, if the business did not operate the entire next preceding year, then the license tax shall be based upon the amount of receipts or sales which bears the same relationship to the actual amount of receipts or sales during such preceding year as the entire year bears to such time which said business was operated during such preceding If the operation of such business did not commence until on or after January first of the then current license year, the gross receipts or gross sales referred to are the actual gross receipts of such business for the then current year, estimated at the time of the issuance of the license, and adjusted when the actual amounts are available.

SECTION 12. DEFINITION OF NUMBER OF EMPLOYEES. Where the amount of the license is based upon the number of employees employed in the business during the next year preceding the then current license year, the number of employees shall mean the average number of employees computed by adding the number of employees at the end of each month and dividing by twelve (or by the number of months the business was conducted if less than the entire preceding year). If the operation of such business did not commence until on or after January first of the ten current license year, the number of employees referred to would be the average number of employees of such business, estimated at the time of the issuance of the license, and adjusted in accordance with the number

of employees actually employed during such year and adjusted when the actual number becomes available.

SECTION 13. DEFINITION OF WHOLESALE SALE. The term "wholesale sale" means a sale to a merchant, jobber, dealer, or to any person for resale and shall include, among other things, sales of building materials to contractors for use in their business and sales to schools, hospitals, and other similar institutions. Anything herein to the contrary notwithstanding, a person shall be entitled to the wholesale rate only if more than eight percent (80%) of his gross receipts are from wholesale rate of license tax must be able to produce sufficient records or other information to prove sales at wholesale in the required percentage, or else the license at the retail rate shall apply.

SECTION 14. LEASED DEPARTMENT. Each person operating what is commonly known as a leased department in a department store shall pay a license on each department so leased, according to a proper classification of the business so conducted as provided for in this ordinance.

SECTION 15. PAYMENT OF LICENSE BY CHECK. Whenever a license or license receipt shall be issued in return for any check, the same shall not be valid or of any force or effect unless such check shall be duly paid and honored upon presentation to the drawee.

SECTION 16. AUDIT OF RECORDS. Upon demand by the City Clerk of the City, or his authorized deputy, auditor, or representative, it shall be the duty of any person subject to or holding a license from the City of Roanoke to furnish such City Clerk, or his authorized deputy, auditor, or representative, without delay, all such information as may be required for determination of the proper classification of such person for license taxation purposes, or for determination of the correct amount of license tax to which such person is subject, and to that end it shall be the duty of such person to submit to the City Clerk, or his authorized deputy, auditor, or representative, for inspection and examination, during reasonable business hours, at such person's place of business in the City or its police jurisdiction, all books of account, invoices, banks statements, sales tax returns, state and federal income tax records, reports and memoranda containing entries showing the amount of purchases, sales, receipts, inventories, and information from which the correct license classification of such person may be ascertained, and the correct amount of such license to which such person is subject may be determined. It shall be unlawful for any person to fail or refuse to perform any duty herein imposed, or to obstruct or interfere Clerk or his authorized deputy, auditor, or with the City representative in obtaining information necessary or convenient for determination of the proper license tax of such person. Each day's failure or refusal to perform any duty herein imposed shall constitute a separate offense.

SECTION 17. INADEQUATE RECORDS. If any person subject to or holding a license from the City of Roanoke does not have in his possession, or under his control, in the City of Roanoke, or its police jurisdiction, true and intelligible books of account, invoices, bank statements, sales tax records, state and federal income tax records, reports or memoranda correctly showing the data and information necessary for determination of the classification to which such person belongs, and for determination of the correct amount of license tax due, or if, having in his possession or under his control such records, he shall fail or refuse to submit and exhibit the same for inspection and examination as herein required, then in either event, it shall be the duty of the City Clerk to ascertain, from such information and data as he may reasonably obtain, the license tax classification of such person, and the correct amount of license tax due from such person, and the assess the same amount against such person, and to give such person notice of said assessment, and to demand of such person immediate payment of the amount of such license tax ascertained to be due, less an amount such person may have theretofore paid upon such license tax. If the amount of the license tax so ascertained and demanded is not paid within ten (10) days after receipt of notice of the assessment and demand for payment thereof, the City Clerk shall notify such person by registered mail that at a time and place specified in said notice, he will apply to the City Council for a revocation of such person' license. At the time and place so specified, such person may appear before the City Council in person or be counsel, one or both, and show cause, if any there be, why said license shall not be revoked. At any such hearing, and for all other At any such hearing, and for all other purposes, the decision and determination of the City Clerk as to the classification and the amount of the license tax due shall be deemed correct and final, unless and until it be satisfactorily shown that such decision and determination is incorrect.

SECTION 18. LICENSE TAKES HIGHEST CLASSIFICATION. Whenever more than one license classification under this license schedule shall apply to any business, that classification shall apply which provides for the highest amount of license unless otherwise provided, and in the event a license under a classification for a smaller amount of license is erroneously issued, the city Clerk is authorized and directed to recall and cancel the same as having been erroneously issued and require a license under the classification calling for such highest amount of license.

SECTION 19. INTERSTATE COMMERCE. No provision or requirement of this ordinance, or any amendment or modification thereto which may hereafter be made, shall be construed or applied so as to impose any unlawful tax or unlawful burden on either interstate commerce or any activity of the state or federal governments.

SECTION 20. PENALTY FOR VIOLATING ORDINANCE. Any person, firm, corporation, association, company, partnership or agency, or the agent, servant, employee or representative of such person, firm, corporation, association, company, partnership or agency,

violating any provision or requirement of this ordinance shall be guilty of a misdemeanor against the City of Roanoke and shall upon conviction thereof be punished by a fine of not exceeding Two Hundred Dollars (\$200.00) and by imprisonment or hard labor for the City not exceeding six months, one or both.

SECTION 21. ISSUANCE FEE. An issuance fee of One Dollar (\$1.00) shall be charged by the City and paid by the licensee for the issuance of each license.

SECTION 22. LIEN FOR LICENSE. On all property, both real and personal, used in any business, as the word "business" is hereinbefore defined, for which a license is required herein, the City shall have a lien for such license, which lien shall attach as of the date the license is due and shall be superior to all other liens, except the lien of the state, county, and City for taxes and the lien of the state and county for license. Such lien may be enforced by attachment or in equity.

SECTION 23. REMEDIES CUMULATIVE. The City shall also be entitled to utilize all other remedies authorized by law in connection with the licenses required and provided for in this ordinance, and particularly those authorized by Article 4 of Chapter 15 of Title 37, Code of Alabama, as amended, and as the same may be hereafter amended. All remedies and actions authorized or provided for are cumulative and shall not be construed to repeal, modify, alter or change any other civil or criminal process or remedy authorized by law in connection with municipal licenses or excise taxes.

SECTION 24. REPEAL OF OTHER ORDINANCES. All ordinances and parts of ordinances heretofore adopted that are in conflict with the provisions of this ordinance are hereby repealed, but the following special ordinances, as now amended and as each may be hereafter amended, are expressly not repealed or modified by this ordinance and remain in full force and effect, to-wit:

The ordinance generally known as the City's Sales Tax Ordinance adopted, on to-wit March 8, 1965.

The ordinance generally known as the City's Cigarette Tax Ordinance adopted, on to-wit August 23, 1954.

The ordinance generally known as the City's Gasoline Tax Ordinance adopted, on to-wit, December 10, 1931.

SECTION 25. POWER TO CHANGE LICENSES. Nothing herein contained shall limit or abridge the right of the City, through its governing body, to change, alter, amend, decrease, increase, or revoke any license herein provided for, nor to limit or abridge the right of the City, through its governing body, to require and provide for license for businesses in addition to those herein provided for.

SECTION 26. SEPARABILITY. Each and every provision, requirement, subsection, section, schedule, or paragraph of this ordinance is hereby declared to be an independent provision, requirement, subsection, section, schedule, or paragraph, and the holding of any provision, requirement, subsection, section, schedule, or paragraph to be void or invalid shall not affect any other provision, requirement, subsection, section, schedule or paragraph hereof, and it is hereby declared that the other provisions, requirements, subsections, sections, schedules or paragraphs of this ordinance would have been enacted regardless of the provision, requirement, subsection, section, schedule or paragraph which might be held void or invalid.

SECTION 27. SECTION HEADINGS. The section heading contained in this ordinance are inserted for convenience only and shall not be construed in any way so as to limit or restrict the wording of such sections.

SECTION 28. EFFECTIVE DATE. This ordinance shall become effective on January 1, 1995 and shall continue in effect from year to year thereafter, except to the extent that the same may be hereafter amended or repealed.
