ORDINANCE NO.603

AN ORDINANCE PROHIBITING SELLING OR SOLICITING FROM OCCUPANTS OF VEHICLES UPON THE PUBLIC STREETS OR WAYS OF THE CITY OF ROANOKE OR ITS POLICE JURISDICTION; AND PROVIDING THE PENALTY FOR SUCH OFFENSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROANOKE, ALA-BAMA AS FOLLOWS:

Section 1. It shall be unlawful and an offense against the City of Roanoke for any person to stand or be upon the traveled portion of any street or public way, or in any safety zone or upon any safety island situated in any street or public way, in the City of Roanoke or its police jurisdiction for the purpose of selling or offering to sell any thing to or soliciting donations, contributions or memberships from occupants of vehicles using said street or public way.

Section 2. Any person found guilty of violating any of the provisions of this Ordinance shall be fined in an amount not exceeding the sum of \$200 and may also be sentenced to hard labor for the City or to imprisonment in the City Jail for a period not exceeding six months, one or both, in the discretion of the Court trying the case.

Section 3. This ordinance shall become effective immediately upon its adoption and publication as required by law.

ORDINANCE NO.604

AN ORDINANCE AMENDING THE PRIVILEGE LICENSE ORDINANCE OF THE CITY OF ROANOKE, ALABAMA, PERTAINING TO LICENSE FOR MEDIUMS

BE IT ORDAINED BY THE CITY COMMISSION OF ROANOKE, ALABAMA:

That schedule 35 of Ordinance No. 543 the Privilege License Ordinance of the City of Roanoke, Alabama, be, and the same hereby is amended to read as follows:

Mediums - Each medium, fortune teller, palmist, clairvoyant, crystal gazer, divine healer, spiritual reader, or similar professeion whether or not any fee is charged directly or indirectly or whether or not any gratuity is accepted shall pay a license tax per week of \$250.00.

The provision for weekly installment payments as set out by this ordinance shall not apply to any of the above stated persons, entertainments or businesses who establish a permanent place of business of the above state type at an established location within the city or the police jurisdiction, of the above stated type which has such permanent location within the city or police jurisdiction shall pay an annual license of \$500.00 for those within the city or \$250.00 for those within the police jurisdiction as per Section 3 of Ordinance No. 543.
