RESOLUTION NO. 609-A

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROANOKE, ALABAMA REQUESTING THE ALABAMA SPECIAL CARE FACILITIES FINANCING AUTHORITY OF THE CITY OF MONTGOMERY TO MAKE A LOAN FOR FINANCING EQUIPMENT TO BE UTILIZED AT RANDOLPH COUNTY HOSPITAL.

WHEREAS, Randolph County Hospital Association, which operates Randolph County Hospital in Roanoke, Alabama is (a) a public entity, which is a user within the meaning of Code of Alabama 1975, Section 11-62-1 (12), (b) a hospital within the meaning of Section 1861 of the Social Security Act and (c) is duly authorized and licensed to operate its facilities under the laws, rulings, regulations and ordinances of the State of Alabama and the departments, agencies and political subdivision thereof;

WHEREAS, Randolph County Hospital Association, d/b/a Randolph County Hospital, wishes to obtain a loan in an amount not to exceed \$45,000.00 from the Alabama Special Care Financing Authority of the City of Montgomery to finance certain necessary and desirable equipment which is a part of a "Facility" within the meaning of Code of Alabama 1975, Section 11-62-1 (8) at its hospital facility in Roanoke, Alabama; and

WHEREAS, Randolph County Hospital Association, d/b/a Randolph County Hospital, has requested the City Kouncil of the City of Roanoke, Alabama the Governing Body of said municipality, to consent to proposed loan.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1.
